

- On 28th day of December, 2012 the said Partha Pratim Basu tendered his resignation from the post of a member of the said Trust, which was again admitted and accepted by

the President and the Trustee Board in recognition of such resignation has given effect to the same and has acted in accordance with law.

- On 30th day of September, 2013 the said Rama Chakraborty tendered her resignation from the post of a secretary of the said Trust, which was again admitted and accepted by the President and the Trustee Board in recognition of such resignation has given effect to the same and has acted in accordance with law.
- 9. Thus between May 2009 to September 2013 the said Sushil Dutta, Tapan Kumar Chakraborty, Partha Pratim Basu and Rama Chakraborty have retired from their respective posts of the said Trustee Board and the Continuing Trustees are desirous of recording the same and the original copies of the resignation letters are collectively annexed hereto and marked with the letter "A" and the same shall be construed as an integral part of these presents.


